Receipt of Handbook Information

You understand that all students will be held accountable for their behavior and will be subject to disciplinary consequences as determined by the Superintendent or designee.

Release of Directory Information

Regarding student records, federal law allows Arrowhead Elementary District #75 to release directory information (see student handbook under "Directory Information") on your child unless you object in writing to the release of any or all of this information. This objection must be filed with the school principal or designee within ten (10) school days of the time this handbook was given to your child. Specific directory information might be included in the following examples of school activities:

- Listing your child's name on party lists (Valentine's Day, etc.)
- Posting of your child's birthday on our birthday bulletin board
- Printing your child's picture and name in the school yearbook
- Publishing awards or accomplishments in the Livingston Enterprise and/or school newsletter (including Honor Roll, GPA, Student of the Week, etc.)
- Photographing, filming, and/or interviewing your child by area TV stations and the Livingston Enterprise for educationally related stories
- Printing of your child's name in the programs for music concerts, holiday programs, award ceremonies, Spelling Bee and Science Fair.
- Listing your child's name for team or activity rosters (may include height, weight, year in school)
- Listing of names in the 8th grade graduation program (may include honors designation)

As a matter of practice, we do not release information to persons or agencies that DO NOT have a special need to know. In exercising your right to limit release of this information, you must attach a letter of request stating which directory information you do not want released and to whom

State Level Electronic Student Photo Directory

The 2019 Montana Legislature passed Senate Bill MTSB40 requiring the OPI (Office of Public Instruction) to create and maintain an electronic directory photograph repository of all Montana public school students. The purpose of this photo repository is solely for assisting law enforcement officials in locating a student that has been identified as a missing child.
